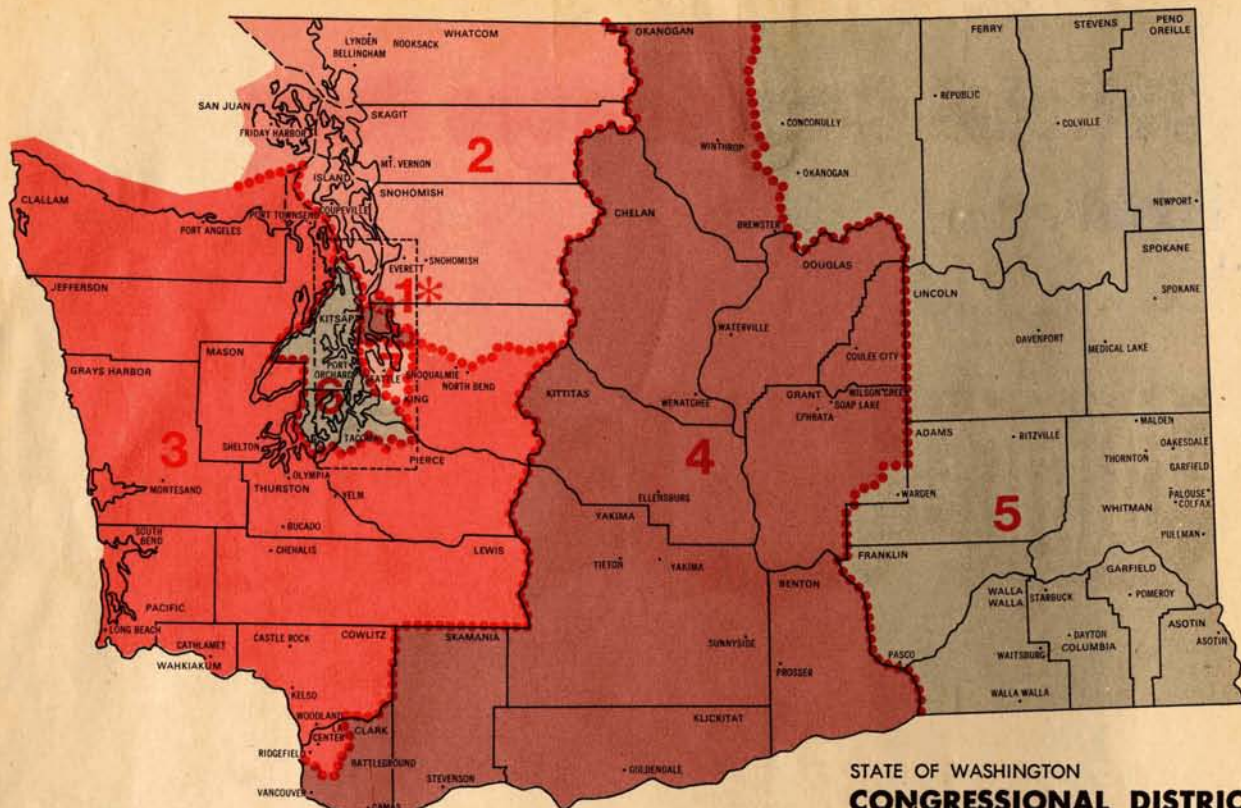

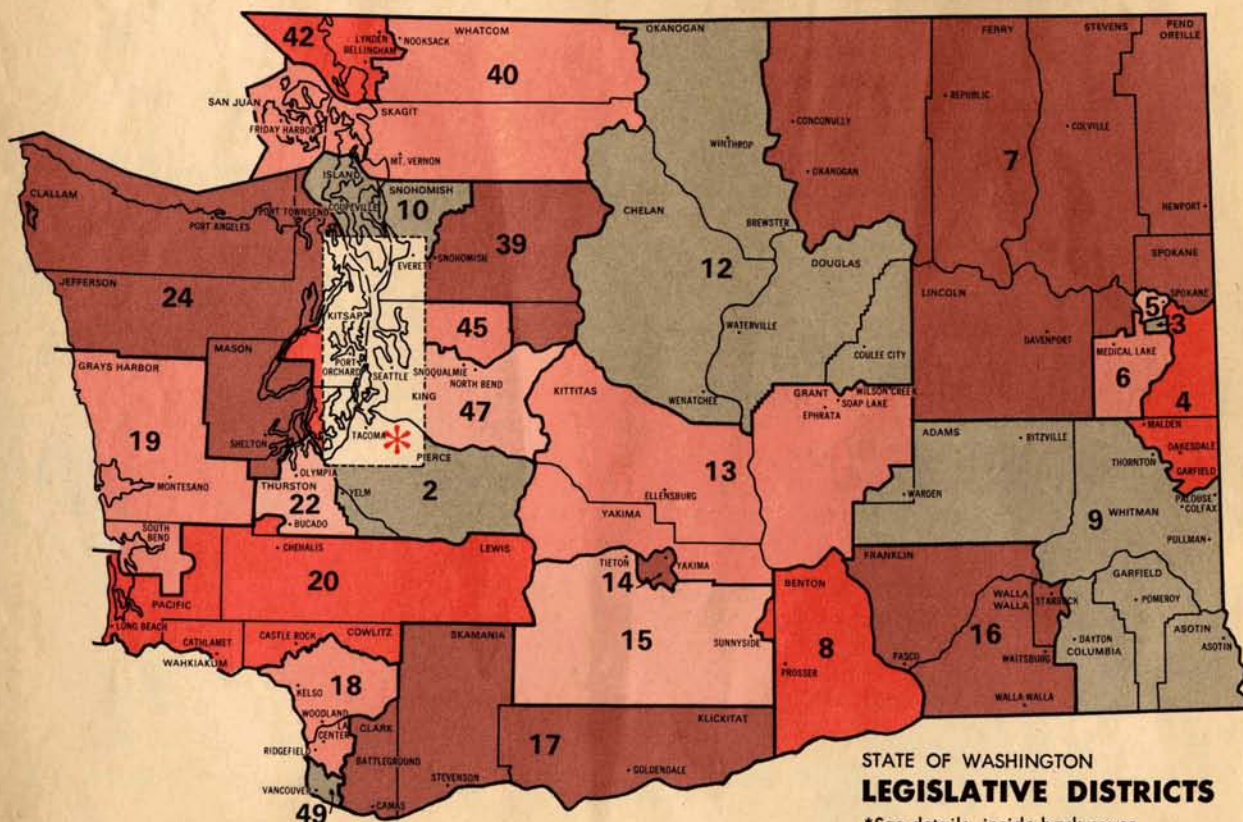

## A WORD ABOUT THE CANDIDATES PAMPHLET . . .

The Secretary of State is required by law to publish a Candidates Pamphlet preceding each state general election. In the preparation of this pamphlet, every nominee for a contested Federal or state office has been given the opportunity to provide a photograph and statement of qualifications.

In past elections, it has been possible to combine the Candidates Pamphlet with the Voters Pamphlet (relating to issues) making a single publication. This year, with a record number of state measures, the size of the Voters Pamphlet (112 pages) created unusual production problems.

It was determined that savings of more than \$125,000.00 could be made by printing a separate Candidates Pamphlet. In addition, the voter is getting two convenient pamphlets instead of one unwieldy over-sized publication of more than 200 pages.

We trust this decision to issue this Candidates Pamphlet as a separate publication will be accepted as in the best interest of the citizens of the State of Washington.

In this election year, approaching the 200th anniversary of our country, let us look closely at where we have gone over the last four years, and where we will go under a McGovern-Shriver Administration.

The incumbent administration has failed to cope with crucial problems both abroad and at home.

Administration spokesmen tell us they have a plan to end the war in Vietnam. Yet four years after we heard the promise of peace, the Indochina war continues to rage.

Administration spokesmen tell us that we should reelect the President. Yet prices and corporate profits continue to rise without evidence of control. Wages are held down, and union contracts are reduced and negated by the Cost of Living Council. Homeowners' taxes go up, and instead of tax reform the Nixon Administration proposes a Value Added Tax, a form of national sales tax.

Many of Washington's leading industries, aircraft and timber for example, have been severely depressed by high interest rates and galloping inflation. As of this June, 137,000 Washington citizens were unemployed, 8.7 per cent of the work force. For the Seattle-Everett area, the rate stood at 10.1 per cent, with 68,700 unemployed. Outside of Alaska, Washington has the highest unemployment rate in the nation. Statewide, as of June, 228,000 Washington citizens were receiving food stamps.

Our nation needs new leadership: policies which will use the national resources to meet the people's needs. The time has come for a reform administration, led by George McGovern and Sargent Shriver.

A Democratic administration will restrain prices, and not just wages. A McGovern-Shriver administration will not permit companies to increase prices more than necessary to offset increased costs.

A Democratic administration will close tax loopholes, reform the federal tax structure to reduce inequities, provide relief for the middle income citizen. It will mean jobs in depressed areas. Americans cannot afford 4 more years of the incumbents. Americans do not want 4 more years of inflation, 4 of high unemployment, 4 of high interest rates.

When Richard Nixon entered the White House on January 20, 1969, the United States was at one of the lowest points in its history. We were faltering and losing ground. Since that time the President has shown how statesmanship and positive action could reverse those trends.

Every effort has been made to bring peace to Vietnam without sacrificing the South Vietnamese people. 500,000 have been brought home from Vietnam, casualties reduced, spending cut by two-thirds.

The President negotiated agreements with the Soviet Union and initiated improved relations with China. He has sought to relieve tensions in other troubled areas of the world.

The Nixon administration has taken strong action to dampen inflation and increase employment. The President initiated a 90-day wage-price freeze, followed by more flexible controls, and introduced tax cuts to stimulate the economy. The inflation rate has been cut in half and the Gross National Product has expanded under his leadership. To relieve tax burdens at state and local levels, the administration's federal revenue sharing plan has been enacted.

Law enforcement policies of the Nixon-Agnew administration have been successful, with half our major cities having decreased crime.

The Environmental Protection Agency was established to combat threats to our environment. Environmental funds have increased over 500%.

The President's health care proposals are designed to guarantee better medical care for all U.S. citizens and find cures for cancer and sickle cell anemia. The drug abuse menace is being attacked.

Young Americans have been helped by the President's signing into law the bill giving 18-year-olds the right to vote and by his overhaul of the selective service system. Older Americans benefit from the President's proposals which increased Social Security payments by more than one-third.

More women and more minority citizens have been given positions of responsibility than in any previous administration. Positive actions, not empty rhetoric, show the President believes in full participation in our society by all citizens.

John G. Schmitz, Congressman from California, accepted the national American Party nomination at Louisville, Kentucky August 3, 1972. He is carrying on the work of Governor George Wallace, who was unable to continue after the nearly successful attempted assassination. The Independent Party, Washington state affiliate of the National American Party, also nominated Schmitz at its September 19th convention in Seattle. Schmitz pledges he will

"keep sending the message" as Wallace did, to oppose mandatory bussing, gun controls, additional high taxes, inflation (always caused by government spending and taxation), and all the other hair-brain schemes which have become cornerstones in the other two national parties. Congressman Schmitz served for six years in the California Senate, was elected to U.S. Congress and re-elected by the largest vote given that year. Congressman Schmitz summarizes his platform in two essential planks, 1. Foreign Policy, "Never go to war unless you intend to win;" and, 2. Domestic Policy, "Those who work should live better than those who won't." While serving as state senator, Schmitz was chairman of the Local Government Committee. In Congress, he was elected to serve on the major House Committee on Interstate and Foreign Commerce, and on the House Internal Security Committee. Tom Anderson, well known agricultural journalist and most quoted humorist with his witty and dynamic speaking abilities, was both the popular nominee and personal choice of presidential candidate, John G. Schmitz. Anderson is a 1934 graduate of Baylor Military Academy and of Vanderbilt U. A Tennessee resident, his long career includes securities business, U.S. Navy officer, magazine publisher and owner, weekly columnist, and winner of many pro-American awards. Through his weekly opinion column, called "Straight Talk," Anderson is unquestionably the most widely quoted editor in the South and the most widely read farm editor in America. He is a past president of the American Agricultural Editors Assn., and holds an honorary doctor of law degree from Bob Jones University.

Capitalism is faced with recurrent crises that have punctuated capitalism's existence intensity.

In these crises society has again and again faced an absurd catastrophe: an epidemic of "overproduction," with millions of workers deprived of their livelihoods because they have produced too much.

Why? Because capitalist industry does not operate primarily to satisfy social wants. It produces to sell at a profit. And whenever more goods and services are being produced than can be profitably sold, capitalist industry naturally cut back its operation.

The most dangerous stimulant is inflation. Almost 40 years of government deficit spending has inflated the national money supply and thus depreciated the dollar to a fraction of its former value.

Moreover, an acceleration of inflation in recent years pushed prices so high that American products found themselves undersold by foreign products here at home as well as abroad.

The fierce competition in the World's market places has compulsively driven American capitalism to revolutionize technology. Each improvement in the methods or tools of production that increases the workers' productivity also increases the stockpile of goods already in the glutted market.

A total economic collapse is in the capitalist cards. It will blast any remaining illusions workers may have that comfortable, secure lives are possible for them within capitalist society.

The Socialist Labor Party's program calls upon the workers to unite politically and industrially. Political unity will enable the worker majority to demand a democratic mandate for social ownership of industry and production. Industrial unity will supply the indispensable force with which to enforce and execute that mandate.

The workers will collectively own and control the industries and social services, to be administered through a Socialist Industrial Union government composed of democratically elected representatives from all the industries. The industrial democracy of Socialism will bring the highest, fullest freedom the human race has ever known.

erated on the opposite principle, that the state has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the life of the individual and seize the fruits of his labor without his consent. We, on the contrary, deny the right of any government to do these things, and hold that the sole function of government is the protection of the rights of each individual: namely, (1) the right to life—and accordingly we support prohibiting the initiation of physical force against others; (2) the right to liberty of speech and action—and accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property—and accordingly we oppose all government interference with private property, such as confiscation, nationalization, and eminent domain, and support laws which prohibit robbery, trespass, fraud and misrepresentation. Since government has only one legitimate function, the protection of individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. Men should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders on a free market; and the resultant economic system, the only one compatible with the protection of man's rights, is laissez faire capitalism. "We the candidates of the Libertarian Party, pledge to uphold the principles of the party, and will hold ourselves accountable for our actions."

## STATEMENT OF PRINCIPLES

We, the members of the Libertarian Party, challenge the cult of the omnipotent state, and defend the rights of the individual. We hold that each individual has the right to exercise sole dominion over his own life, and has the right to live his life in whatever manner he chooses, so long as he does not forcibly interfere with the equal right of others to live their lives in whatever manner they choose. Meeds is concerned about runaway health costs and spotty insurance coverage. He was one of the original sponsors of Medicare and now supports comprehensive national health insurance. He co-sponsored the Older Americans Act and supports increased Social Security benefits.

Meeds believes solving the drug problem will take care of half the crime problem. He wrote the Drug Abuse Education Act to tell young people the truth about drugs. A former prosecutor, he believes in both strict law enforcement and prevention.

He's worked hard to put more fairness and less favoritism in our tax laws by plugging loopholes.

Meeds works hard. His attendance record over the past eight years is one of the highest in Congress. But he comes home often to talk to people, listen and learn their problems. Lloyd Meeds works hard and he helps people.

of Redmond, Bill Reams has developed an understanding and concern for the second district and its people.

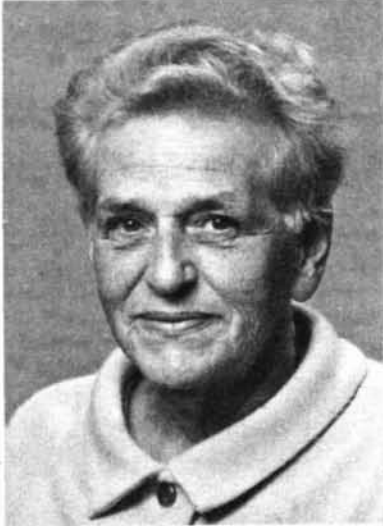

Congresswoman Julia Butler Hansen, dean of the State delegation to the House of Representatives, chairman of the Appropriations Subcommittee on the Dept. of Interior and Related Agencies, has represented the Third Congressional District continuously since 1960.

Mrs. Hansen is the only woman member of Appropriations and is the first woman in congressional history to head an Appropriations Subcommittee, which reviews the funding proposals for programs of the U.S. Forest Service, National Park Service, Bureau of Indian Affairs, Youth Conservation Corps, Bureau of Land Management, Bureau of Outdoor Recreation, Bureau of Sports Fisheries and Wildlife, the Smithsonian Institution, National Federation on the Arts and Humanities, and many others.

Mrs. Hansen has volunteered for activities far beyond her heavy workload. She helped organize the prestigious "Democratic Study Group," comprised of the most forward looking progressive House members. She helped draft several significant House reform measures—including the one abolishing the old "seniority" rule for automatically elevating committee members to chairmanships.

The quality and thoroughness with which Mrs. Hansen fulfills her duties were probably best demonstrated during her past term of office. After completing presentation of her appropriations bill, she

was given a spontaneous bi-partisan standing ovation by her colleagues—a rare occurrence.

Mrs. Hansen's is the state's largest district, containing all or parts of roughly one-third of the state's counties. 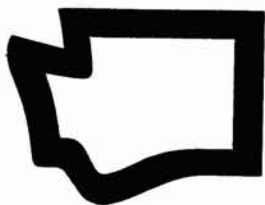

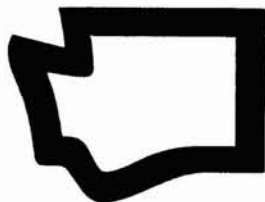

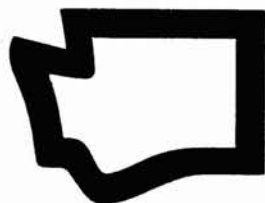
The time is now when we must find a solution to the many crises that are making shambles of the lives of so many of our citizens.

To be valid an absentee ballot must be voted (and the return envelope postmarked) no later than the day of the election.
