

Lt. ORRIS HAMILTON stopped in the office July 30 to shake hands around and say hello to everybody. He looks grand, and was his usual spic and span self. He is on leave after just arriving in this country from the European theater via the Queen Elizabeth. Orris has been with the 7th Army all through the war. They got stymied around Strasbourg for a while until we. crossed the Rhine, then they started making tracks, but fast, taking Mannheim, then Stuttgart, and ending up in the southern part of Austria in the Bavarian Tyrol, right in the mountains near Brenner Pass ---- they were there when the end of hostilities came. He says the country is perfectly beautiful --- something out of this world---story book land----however he also said it reminded him of this part of Washington. (I suppose if we had a few little chalets strewn about on the side of the mountains --- and learned to yodel --- we'd be doing all right.) She looked grand and mighty snappy in her uniform. I had received a letter from Helen not long before---I'll quote it here so you all can know what she has been doing. She says she's crazy about her job and would like to stay on in the WAC as long as she can:

Fort Dix, N.J.

"Dear Evelyn:

It was grand to get the current issue of the Bulletin. I was about to think that it had been suspended. It has been a perfectly grand gesture from you all and I can't tell you how much I have appreciated it. I can imagine that it has meant even more to those who are much farther away.

August 23 marked 2 years at Fort Dix for me. They have been a very busy and a very happy 2 years if one has the right of happiness at a wartime job. This week sort of rounded out a cycle for me when part of the 4th Div. came through for redeployment. They were the division in training when I came here just out of OCS. There weren't a lot of familiar faces but the old shoulder patch brought back a lot of memories. See by PM, the only New York paper we are getting here now due to the strike, that the 44th is due in on Friday. That is the division Orris Hamilton is with. The advance detachment of the 30th is due in some time next week. Hope that Smith and Shirley are fortunate enough to be aboard. It is thrilling to see the arrivals published. For so long all ship movements were so secretive, as you know. That be autiful overhead drive along the Hudson is all boarded up so that all you can see are Liz's and Mary's smokestacks. They never could conceal their arrival and departure because they couldn't hide them. These I don't see from my window like we used to look at Olympia harbor, but only after a couple of hours' trip by bus and rail, One of the most attractive features of Dix is its proximity to NYC and, for those who like it, Philly.

Wanted to come home on leave this summer but can only get 10 days which would be useless unless by plane. That is terribly expensive and we are not allowed to contact the ATC, even the there is a base right here and planes going to Calif. daily. Our commanding general is a sticker for none of his officers riding on Army planes. Even on commercial planes they still have priorities and leaves is not one of them. I did toy with the idea of asking for a transfer to the Coast but have such a swell and interesting job here that I am awfully loathe to give it up. With the Post crowded (the other day there were 67,000 troops here) the War Dept. theaters (we have 7) are packed all of the time, regardless of the picture. We are even running extra performances to take care of the crowds. GIs love movies and I love being instrumental in seeing that they get them promptly and in the pleasantest surroundings possible. The Post Central Fund just appropriated \$5000 to pretty them up (the theaters) and we are having a whale of a time spending it.

The Army Motion Picture Service gets all film before it is released commercially, so when Radio City Music Hall has a World Premiere of Valley of Decision or sumpin'---pooh, we had it a month ago. They are a loyal little gang and have always very kindly overlooked the fact that half the time I'm not nearly as smart as they are. All of which goes toward making the job just that much pleasanter.

One of the boys who came back from the So. Pacific about 6 months ago and has been assigned to the Theaters since coming here just came in to tell me that his name was called to go to the Separation Center for discharge on points. He has 106. Never have I seen a happier little face. He is only 22. Gee, it is so much more fun to see them come home than it was to see them go. They are a crazy, goofy, wonderful bunch. I haven't any qualms about how the GI is going to settle down into society again. There are a lot of spirits that the war hasn't broken and they are rarin' to go. What a wonderful bunch of Young Democrats they ought to make. I know when I get home that I am going to have to settle down to just the Democratic Club and forget the Young business. Bake used to kid me about that all the time.

Give my regards to everyone. Tell Jennie that I haven't forgotten her and mention her frequently. If you ever see Morrie Hulander throw my hat in. Norie and I used to write occasionally and the cessation, I am afraid, is my fault. Tell Edna, Olive, Naomi, Valora, Billsie and Reatha I'll be seeing them. Owe Reatha a letter but I know she has been too busy with Presidents and stuff to feel slighted. The male personnel changes so rapidly around the office that I can't keep track of who is there and who is new. Anyway, "hello" everybody. Looking forward to the next issue of the Bulletin.
