A RESOLUTION OF THE CITY OF BONNEY LAKE, PIERCE COUNTY, WASHINGTON, AUTHORIZING THE MAYOR TO SIGN A MEMORANDUM OF UNDERSTANDING WITH THE SUMNER-BONNEY LAKE SCHOOL DISTRICT TO RENEW THE INTERLOCAL AGREEMENT FOR SUPPORT OF THE SUMNER FAMILY CENTER COORDINATOR FOR 2021/22.


WHEREAS, in 2007 the City of Bonney Lake, by Resolution No. 1712, and the Sumner School District entered into an Interlocal Agreement (ILA) to contract for a Family Center Coordinator position whereby the parties agreed to share the expense for said coordinator's salary and benefits. Section 4.1 of said Agreement provided for renewal of the Agreement for successive one (1) year terms by mutual agreement of both parties; and

WHEREAS, the City Council desires to renew said agreement for 2021/22 at the support level indicated in the Memorandum of Understanding, attached hereto as Exhibit "A";


NOW THEREFORE, the City Council of the City of Bonney Lake, Washington hereby resolves as follows:

The Mayor is hereby authorized to sign the Memorandum of Understanding (MOU), attached hereto as Exhibit "A".

Memorandum of Understanding


- Parties.** The City of Bonney Lake, a Washington municipal corporation (“City”), and the Sumner School District, a common school district and municipal corporation of the State of Washington (“District”), hereby enter into this Memorandum of Understanding this 22 day of February, 2022.
- Background - Agreement.** In 2007 the City of Bonney Lake and the Sumner School District (collectively the parties) entered into an Interlocal Agreement (ILA) to contract for a Family Center Coordinator position whereby the parties agreed to share the expense for said coordinator’s salary and benefits. Section 4.1 of said Agreement provided for renewal of the Agreement for successive one (1) year terms by mutual agreement of both parties.
- Renewal.** The parties wish to continue to cooperate and continue to cost share the salary and benefits of a Family Center Coordinator for fiscal years 2021/22. To that end, this MOU is entered into to signify both parties renewal of the agreement for 2021/22.
- City Contribution.** The City of Bonney Lake has budgeted twelve thousand dollars (\$12,000) annually in the adopted 2021-2022 Biennial Budget as its contribution towards the Family Center Coordinator position for 2021 and 2022, which shall be due and payable within 30 days of receiving an invoice or statement from the Sumner School District for said contribution.


