**PROCLAMATION BY THE GOVERNOR  
TERMINATING STATES OF EMERGENCY**

**12-19**

I, Christine O. Gregoire, Governor of the state of Washington, terminate the following proclamations pursuant to RCW 43.06.210:

1. Proclamation 07-02 dated March 6, 2007, which proclaimed a state of emergency for damage from flooding, landslides, and mudslides caused by above-normal rainfall in Skamania County.
2. Proclamation 11-03 dated February 14, 2011, which proclaimed a state of emergency for severe winter storms that caused extensive damage in Chelan, Clallam, Clark, Cowlitz, Grant, Grays Harbor, King, Kittitas, Klickitat, Lewis, Mason, Pacific, Skagit, Skamania, Snohomish, Wahkiakum, and Whatcom counties.
3. Proclamation 11-05 dated April 20, 2011, which amended Proclamation 11-03 and proclaimed a state of emergency for severe winter storms in Jefferson County.
4. Proclamation 12-01 dated January 18, 2012, which proclaimed a state of emergency in the state of Washington for severe snow storms that created extreme weather conditions resulting in road closures impacting delivery of bulk milk, waived driver hours of service rules for drivers of trucks hauling bulk milk, and activated the organized militia.
5. Proclamation 12-02 dated February 19, 2012, which amended Proclamation 12-01 and proclaimed that Proclamation 12-01 remained in effect in Clallam, Clark, Cowlitz, Grays Harbor, King, Klickitat, Lewis, Mason, Pacific, Pierce, Skamania, Snohomish, Thurston and Wahkiakum counties, except for waiver of the driver hours of service rules and activation of the organized militia.
6. Proclamation 12-04 dated March 24, 2012, which proclaimed a state of emergency for a series of severe storms that caused extensive damage in Clark and Mason counties.

7. Proclamation 12-06 dated April 17, 2012, which proclaimed a state of emergency for roadway damage and its effects involving an Interstate 90 overpass in King County.
8. Proclamation 12-08 dated August 14, 2012, which proclaimed a state of emergency for a wildfire and unhealthy air quality in Kittitas and Yakima counties.
9. Proclamation 12-13 dated September 14, 2012, which proclaimed that Proclamation 12-12 remained in effect in all counties East of the crest of the Cascade Mountains and, pursuant to the provisions of RCW 43.06.220(1)(i), to preserve and maintain life, health, property or the public peace, imposed a temporary outdoor burn ban by prohibiting all outdoor and agricultural burning in the area affected until midnight on September 18, 2012.
10. Proclamation 12-14 dated September 18, 2012, which amended Proclamations 12-12 and 12-13, proclaimed that Proclamation 12-12 remained in effect in all counties East of the crest of the Cascade Mountains and, pursuant to the provisions of RCW 43.06.220(1)(i), to preserve and maintain life, health, property or the public peace, imposed a temporary outdoor burn ban by prohibiting all outdoor and agricultural burning in the area affected until midnight on September 24, 2012.
11. Proclamation 12-15 dated September 24, 2012, which amended Proclamations 12-12, 12-13, and 12-14, proclaimed that Proclamation 12-12 remained in effect in all counties East of the crest of the Cascade Mountains and, pursuant to the provisions of RCW 43.06.220(1)(i), to preserve and maintain life, health, property or the public peace, imposed a temporary outdoor burn ban by prohibiting all outdoor and agricultural burning in the area affected until midnight on September 30, 2012.
12. Proclamation 12-16 dated September 30, 2012, which amended Proclamations 12-12 , 12-13, 12-14, and 12-15, proclaimed that Proclamation 12-12 remained in effect in all counties East of the crest of the Cascade Mountains and, pursuant to the provisions of RCW 43.06.220(1)(i), to preserve and maintain life, health, property or the public peace, imposed a temporary outdoor burn ban by prohibiting all outdoor and agricultural burning in the area affected until midnight on October 7, 2012.
13. Proclamation 12-17 dated October 7, 2012, which amended Proclamations 12-12 , 12-13, 12-14, 12-15, and 12-16, proclaimed that Proclamation 12-12 remained in effect in all counties East of the crest of the Cascade Mountains and proclaimed a state of emergency in all counties West of the crest of the Cascade Mountains where fire conditions had become as severe, and pursuant to the provisions of RCW 43.06.220(1)(i), to preserve and maintain life, health, property or the public peace, imposed a temporary outdoor burn ban by prohibiting all outdoor and agricultural burning in the all counties until midnight on October 15, 2012.
14. Proclamation 12-18 dated October 12, 2012, which amended Proclamations 12-12, 12-13, 12-14, 12-15, 12-16, and 12-17, proclaimed that Proclamation 12-12 remained in effect in all counties East of the crest of the Cascade Mountains, terminated the state of emergency in all counties West of the crest of the Cascade Mountains, rescinded the temporary burn ban prohibiting all outdoor and agricultural burning in counties West of the crest of the

Cascade Mountains at 8 a.m. on October 13, 2012, and retained the temporary burn ban prohibiting all outdoor and agricultural burning in counties East of the crest of the Cascade Mountains until midnight on October 15, 2012.
